

# SCREEN SENSATION® CRAFTER OF THE YEAR AWARDS 2018 COMPETITION TERMS & CONDITIONS

These terms and conditions set out the legally binding contract between Craft Channel Productions Limited (**Craft Channel Productions**) and you in relation to the Screen Sensation® Crafter of the Year Awards Competition (**the Competition**).

You will be deemed to accept these terms and conditions if you enter the Competition.

## ENTRY and ELIGIBILITY

To enter the Competition, entrants must submit a minimum of three (3) completed screen printed projects, with at least one project representing each of the following categories: (i) Papercraft and Cards; (ii) Textiles and Fabric; (iii) Mixed Media/Home Decor. Entrants may submit additional projects, however there must be at least one project for each category for the entry to be accepted.

Each project must have been screen printed utilising the Screen Sensation® or Screen Sensation Compact®, Screen Sensation screens, and Screen Sensation Inks. Original designs can be utilised if they have been created with the Screen Sensation® Create Your Own Screen Kit.

Entrants may utilise other techniques to enhance their project submissions, including but not limited to: embossing, glitter, foiling, fabric pens, sewing, embroidery, cross-stitch, watercolour, and painting. These techniques should not take away from the original design elements, keeping the Screen Sensation® products as the main focus of the project.

Entrants must already own the Screen Sensation® kit and necessary supplies to complete their submission projects. No supplies will be provided to entrants.

Entrants must be aged 18 or over by 1 August 2018 (if you are not aged 18 by that date, you cannot enter the Competition) and be a UK resident. Proof of identity and age may be required and Craft Channel Productions reserves the right to verify the eligibility of all entrants.

The Competition is not open to employees of Ideal Shopping Direct Limited, Craft Channel Productions Limited or any other of the Ideal Shopping group companies, their families, agents and anyone connected with the Competition.

Photographs of projects will **not** be accepted. Entries deemed incomplete by the judging panel will not be accepted. Entries containing offensive or obscene language or imagery will not be accepted.

## HOW TO ENTER and ENTRY DEADLINE

The closing date for receipt of entries is close of business on 1 August 2018 (**the Competition Deadline**). All eligible entries received by this time will automatically be

included. Any submissions received after the Competition Deadline will not be considered.

All submissions must include one completed Entry Form and the minimum of three (3) completed screen printed projects that are fully finished and utilise the Screen Sensation® products (as detailed above). A submission must include all of the required components to be entered into the Competition.

Please note that submission projects will not be returned to the entrant and may be utilised in broadcast productions on Create & Craft TV as well as in photo and video promotional materials for the Screen Sensation® brand and the Crafter of the Year Awards competition.

## **JUDGING and PRIZES**

All eligible entries will be forwarded to a judging panel, comprised as follows, who will select the winners:

- a) Wendy Hunter – Screen Sensation® Brand Manager
- b) Stephanie Weightman – Screen Sensation® Creative Director
- c) Kathleen Turner – Creative Development Assistant Manager.

The winning designs will be the ones which, in the opinion of the judges, best showcase the versatility and diversity of the Screen Sensation® products across the chosen mediums.

The winning entries will be selected by the judges on 15 August 2018. All winners will be notified via email or telephone within 30 days of the Competition Deadline. The winners' names will be published on [www.ScreenSensation.com](http://www.ScreenSensation.com) and across the associated social media platforms.

Three (3) prize winners will be selected from all eligible entries received:

- I. **First Prize:** the winner will be awarded the title of Screen Sensation Crafter of the Year 2018 and receive £250, a guided tour for two (2) people of the Create and Craft Studios in Peterborough, UK, two (2) seats at an exclusive Masterclass with a Screen Sensation expert in Chesterfield, UK and will be the subject of a feature article in one of the Craft Channel Productions magazine publications.
- II. **Second Prize:** the winner will receive a guided tour for two (2) people of the Create and Craft Studios in Peterborough, UK, two (2) seats at an exclusive Masterclass with a Screen Sensation expert in Chesterfield, UK and will be the subject of a feature article in one of the Craft Channel Productions magazine publications.
- III. **Third Prize:** the winner will receive two (2) seats at an exclusive Masterclass with a Screen Sensation expert in Chesterfield, UK and will be the subject of a feature article in one of the Craft Channel Productions magazine publications.

The winners must be available to travel to Peterborough, UK and Chesterfield, UK on a chosen date to participate in the Studio Tour and Masterclass. Transportation will **not** be provided or paid for.

Studio Tour and Masterclass event dates will be scheduled to best accommodate the winners' availability; however, only one date will be selected. Craft Channel Productions will not be held responsible if a winner is not available to attend.

All entrants whose entries are received before the deadline and in accordance with terms above will receive two (2) free tickets to the Crafting Live event of their choice before December 2019. With the exception of entry tickets to the event itself, all travel, accommodation and other costs associated with attending the Crafting Live event will be the sole responsibility of the entrants.

The prizes are non-transferable and no cash alternative will be offered to the winners. Craft Channel Productions reserves the right to substitute a prize of equal or greater value at any time. Craft Channel Productions accepts no responsibility for any costs associated with the prize and not specifically included in the prize.

If, in the sole discretion of the judges, none of the entries is of a sufficiently high standard to merit awarding a prize, no prizes, or only second and third prizes, may be awarded. The decision of the judges is final and correspondence will be entered into only at the absolute discretion of Craft Channel Productions.

If a winner does not respond to Craft Channel Productions within 30 days of being notified by Craft Channel Productions, then the winner's prize will be forfeited and Craft Channel Productions shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 30 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these rules, the winner's prize will be forfeited and Craft Channel Productions shall be entitled to select another winner.

## **FURTHER TERMS AND CONDITIONS OF ENTRY**

- 2) There is no fee to enter the Competition.
- 3) There can be only one named entrant per entry. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 4) The Competition is open to Screen Sensation® users of any skill level.
- 5) Craft Channel Productions accepts no responsibility for entries that are lost, delayed, damaged, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of sending or delivery of the entry is not proof of receipt by Craft Channel Productions.
- 6) Submitted projects will not be returned and Craft Channel Productions accepts no responsibility for the loss of or damage to any projects submitted.
- 7) Events may occur that render the Competition itself or the awarding of the prizes impossible due to reasons beyond the reasonable control of Craft Channel Productions. In those circumstances, no liability shall attach itself to Craft Channel Productions.
- 8) Craft Channel Productions reserves the right to, at its absolute discretion, cancel, temporarily suspend, vary or amend the Competition and the terms thereof with or without prior notice (including, without limitation, in the case of anticipated, suspected or actual fraud).

- 11) All entrants hereby license to Craft Channel Productions the use of their projects for display on any company-owned or third-party website or in other media for publicity purposes. Entrants further permit Craft Channel Productions to display their entries in a physical exhibition. The choice of which entries are included in any such exhibition shall be solely made by Craft Channel Productions. Appropriate credits will be given to each item displayed, but Craft Channel Productions shall not be under any obligation to hold such exhibitions, or to include every entry if it does.
- 12) Nothing in these terms excludes or limits Craft Channel Production's liability for losses which may not be excluded or limited by applicable law. Subject to this, Craft Channel Productions shall not be liable to you for any loss or damage which may be suffered by you in relation to your entry to the Competition, including indirect or consequential losses such as loss of profit, loss of goodwill or business reputation, or loss of data suffered by you.

- 13) By entering the Competition each entrant confirms that his/her entry is their wholly-owned creation and to the extent that such entry makes use of any third-party materials, that these materials have been fully cleared for use (unless such materials are no longer protected by copyright or other intellectual property rights). Entrants agree to indemnify and hold harmless Craft Channel Productions from any claims, liabilities, actions or costs made against Craft Channel Productions in relation to any allegation or claim that the entry infringes the intellectual or proprietary rights of any third party.
- 14) Craft Channel Productions may disqualify any entrant whose entry does not comply with these terms and conditions (in Craft Channel Productions' sole opinion) or who, in Craft Channel Productions' sole determination, has acted in a manner that is fraudulent, dishonest or unjust to other entrants including, without limitation, tampering with the operation of the Competition, deceiving, cheating or by harassing or threatening other entrants, the Judges or a representative of Craft Channel Productions.
- 15) These terms and conditions, together with Craft Channel Productions' privacy policy, constitute the whole legal agreement between you and Craft Channel Productions in relation to your entry to the Competition.
- 16) These terms and conditions are governed in accordance with the laws of England and Wales and the English courts shall have exclusive jurisdiction to settle any claims arising out of or in connection with these terms and conditions.
